5.0 Financial Update

The Community Well-Being Fund acceptance requires a member of the HBMHA Executive to attend a photoshoot on Thursday October 11th at 3:30pm in Council Chambers, 21 Queen Street Ripley. The Executive will be unable to host a power skating program in 2018 due to scheduling restrictions and ice availability.

That the Huron-Bruce Minor Hockey Executive ask an amendment to the Community Well-Being Application to redirect funds from the proposed Power Skating program to the Future Pro Goalie Clinic.

6.0 Gate Procedure

The Executive discussed various options for a gate / admission procedure and policy. The Executive explored the benefits of assigning a cash box to each team, as well as having only one cash box at each arena. It was determined that a lock box will be required at each arena and an Executive member will be required to empty the lock boxes three or four times a week.

Susanne Cutting offered to collect the lock box revenue in Lucknow, Natalie Meekins offered to collect the lock box revenue in Ripley. Susanne Cutting and Shaun Scott will continue to formulate a procedure for the gate collection.

7.0 Ice Rental Contracts

The Executive reviewed the cancellation policy at both arenas – Lucknow requires 7 days notice to cancel without penalty, Ripley requires 14 days notice to cancel without penalty. Brad Murray contacted the Community Services Department of Huron-Kinloss to request a reduction in the 14 day policy, but his request was denied.

The Executive will submit a request to Jessica Catto and Mark Hackett to specify charges for unused ice on the invoices, and request that ice is billed monthly. The Executive also discussed submitting a letter to council to freeze the ice rental rate as well as reduce the 14 day cancellation policy requirement.

8.0 Coaches Manuals

Darren Maki briefed the Executive on the Coaches Manual requirements. Troy Snobelen offered to assist with the assembly of the coaches packages. The Executive agreed to host the Coaches Meeting on Thursday, October 4th at 7pm. Brad Murray, Dave Hackney, Darren Maki and Troy Snobelen will collect packages, presentations and information from previous years' RMH and LMH Associations for reference.

9.0 Scheduling Meetings

The Rep and AE team scheduling meeting is taking place on Sunday September 30th at the Wingham Legion.
